Notice from Managed Investment Trusts re 'fund payment'

Mirvac Funds Limited, the responsible entity of the Mirvac Property Trust, considers that the trust is a managed investment trust ("MIT") in relation to its income year ended 30 June 2011, and gives the following notice to you as recipient of a payment of 2.2000 cents per unit for the June 2011 quarterly distribution made on 29 July 2011:

- a) The fund payment, being the part of the payment from which an amount would have been required to be withheld under Subdivision 12-H of Schedule 1 to the Taxation Administration Act 1953 if the payment had been made to an entity covered by section 12-410 of that schedule, is 0.778921 cents per unit and relates to the income year ending 30 June 2011;
- b) The proportion of the fund payment relating to the grossed up amount of discounted capital gains on Taxable Australian Property (TAP) is NIL cents per unit.

Mirvac Funds Limited also provides the following information which forms part of the total distribution of 2.2000 cents per unit.
