

## **TERMS AND CONDITIONS FOR GOLDEN TICKET HUNT GIVEAWAY**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in this **GOLDEN TICKET HUNT GIVEAWAY (“Promotion”)** is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in **AEST Local Time**.

### **ELIGIBILITY**

2. Subject to condition 3, this Promotion is only open to Australian residents (including international students residing in Australia) **aged 18 years or over**.
3. The following are ineligible: (i) employees of the Promoter, the Mirvac Group or any of the tenants or retailers in any Participating Centre or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

### **LIMITS ON ENTRY**

8. Limit of one (1) entry per person per day. Each entry must be completed separately and in accordance with the entry requirements.
9. Each Golden Ticket is single-use only. Once a daily prize has been redeemed, no further prize claims will be accepted for that day.
