

SOUTH EVELEIGH GROCERIES GIVEAWAY TERMS AND CONDITIONS

- 1. Participation in South Eveleigh Groceries Giveaway ("Romeo's IGA \$2K Giveaway") is deemed acceptance of these Terms and Conditions. All times and dates throughout these Terms and Conditions are based on Australian Eastern Standard Time (AEST) or Australian Eastern Daylight Savings Time (AEDST) as the case requires. The "Participating Centre" is South Eveleigh
- 2. Subject to condition **4**, this Promotion is only open to Australian **residents aged 13 years or over**.
- 3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions.
