
**OLIVINE PROMOTION – A LOT OF QUALITY UP TO \$45,000 REBATE
Terms and Conditions**

Background to Promotion

1. Mirvac Victoria Pty Ltd (**Mirvac** or the **Promoter**) recently introduced the A Lot of Quality up to \$45,000 Promotion (**Promotion**).
2. The Promotion will run for a limited time. The Promotion commences on **Wednesday, 13 May 2026** and ends on **Sunday, 31 May 2026 (Promotion Period)**.
3. Under the Promotion, subject to these terms and conditions, an Eligible Buyer (as defined in condition 6) will be entitled to obtain a rebate of:
 - a. \$45,000 (GST inclusive) for the first three qualifying purchasers; or
 - b. \$40,000 (GST inclusive) for all other qualifying purchasers,on the Purchase Price (inclusive of GST) of an Eligible Lot (as listed at the end of these conditions), at settlement provided that the contract for sale for the Eligible Lot is entered into during the Promotion Period.
4. The amount of the rebate applicable to the relevant Eligible Lot is set out in the table at the end of these conditions (**Promotion Rebate**).
5. The following terms and conditions apply to the Promotion. By participating in the Promotion, Eligible Buyers agree to be bound by these terms and conditions.

The Eligible Buyer will only be entitled to take part in the Promotion if the following terms and conditions are satisfied:

6. The Promotion is for buyers who:
 - a. are natural persons over the age of 18 years and are not a company, registered builder, superannuation funds or persons acting as agent on behalf of other persons;
 - b. have not been referred to Mirvac or Olivine by a referring channel agent;
 - c. are not an employee, agent, consultant or related entity of Mirvac;
 - d. enter into an unconditional contract of sale with Mirvac for the purchase of an Eligible Lot (**Contract**) during the Promotion Period.
 - e. pay the deposit required under the Contract on or before the date required by the Contract;
 - f. comply with the terms of the Contract and are not otherwise in default under the Contract; and
 - g. settle the acquisition of the Eligible Lot on or before 26 June 2026 or under the terms of your Contract.

(Eligible Buyer).

7. The \$45,000 rebate is strictly limited to the first three Eligible Buyers. Once exhausted, all remaining Eligible Buyers will receive a \$40,000 rebate.

By participating in this promotion and entering into a Contract, the Eligible Buyer acknowledges and agrees that the Eligible Buyer has not relied upon any statement from Mirvac regarding the availability or amount of any incentive (cash or otherwise) that may be provided by a participating builder.

11. The Eligible Buyer acknowledges and agrees that the Promotion is non-transferrable, non-refundable and cannot be exchanged for cash. All taxes which may be payable as a consequence of receiving or participating in the Promotion are the sole responsibility of the Eligible Buyer.
12. The Eligible Buyer must disclose the contents of this Promotion to any lending institution providing finance to the Eligible Buyer to assist with the purchase of the Property.
